he Ease of Doing Business (EoDB) index is a ranking system established by the World Bank Group which assesses how easily a business is set up right from the registration process. CM Yogi Adityanath's government has taken massive strides in the context. of providing a hassle-free environment for entrepreneurs to set-up bases in the state. With dedicated efforts and hard work, in a very short span of CM Yogi being in power, UP jumped from the 12° position in the Business Reform Action Plan (BRAP) 2017-18 has become an 'Achievers State' today.

Uttar Pradesh had managed to implement 186 of the 187 reforms suggested by the Union government's Department for Promotion of Industry and Internal Trade (DPIIT) under BRAP 19. With the timely implementation of policy decisions, today, Uttar Pradesh is becoming a preferred destination in 'Ease of Doing Business' ranking. Further, the first global summit organised in 2018 had a major role to play in establishing a concrete foundation for UP's success in the rankings.

CM Yogi Adityanath went a step further and added another dimension to 'Ease of Doing Business' by putting fresh impetus to 'Ease of Starting Business', hence all the incentives, concessions and facilitation of various services including single window facility for the investors to expedite the processes and curtail the unnecessary delays in the execution of projects. Addressing key issues faced by entrepreneurs, CM Yogi Adityanath introduced timely interventions to tackle and eradicate corruption, introduced digitisation in the process and made official working transparent.

UP government initiatives for fostering entrepreneurship

- Implementation of the 'Nivesh Mitra' single window system for a one-stop licenses approval system in the state
- Online availability of land bank including its integration with Industrial Information System (11), Indian government, so that a foreign investor can also compare availability of land banks from states level to districts level

PLEDGE FOR A NEW

Leadership and Enterprises for Development of Growth Engine) scheme for industrial development, UP government is adding a new feather to its efforts. The initiative will help establish private industrial parks across the state with the support of the state government.

The first instalment of Rs 1,689.98 lakh has already been disbursed by the CM to developers in UP. The first phase of these parks will be set up in Aligarh, Saharanpur and Kanpur Dehat districts. According to CM Yogi Adityanath, "Kanpur being a defence node, and a private industrial park in Kanpur Dehat is a good initiative." These parks will lend support and meet the economic needs of the people. The state government has opened new avenues of investment and industrial development through the PLEDGE initiative, which in turn will create new jobs and revenue streams.

According to the proposal approved

ing industrialists, corporates, consortium of corporates, would be able to develop industrial parks on a 'build own and operate' model. Under the scheme, private players will be incentivised to set up industrial parks on self-owned 10-50 acres of land. which they will have to develop for a designated purpose. The developer would also be provided with certain incentives, such as waivers on stamp duty on procurement / transfer / lease of land. Development of private industrial parks on a cluster model would be given preference.

"I have full faith that entrepreneurs will take maximum advantage of the schemes of the UP government. I also appeal to all other MSME entrepreneurs to come forward to make private parks in their respective areas. Today the world is looking towards India with a positive attitude, similarly, the whole of India is seeing UP as a state of possibilities," stated the CM.

UP's MSME POLICY: SUPPLEMENTING GROWTH

The MSME policy of Uttar Pradesh aims to further boost the growth of the sector by providing a range of incentives and support measures

ttar Pradesh is home to the largest MSME sector in India that contributes significantly to the state's GDP, accounting for over 30% of the total output. The MSME Policy 2022 has created an environment for establishment of MSMEs by providing many incentives:

- 10% to 25% of the project cost to be provided as capital subsidy with a maximum limit of Rs 4 crore
- Stamp Duty exemption for purchase/lease of land for establishment of industries 100% stamp duty exemption for women
- entrepreneurs Subsidy of upto Rs 5 lacs for setting
- national/international quality certification and required equipment
- · For ensuring sustainable industrial growth, environment protection measures are facilitated. A grant of upto Rs 10 crore is provided for setting up of CETPs
- Time bound and online method of incentive disbursement
- A big focus on developing industrial infrastructure. 10 to 50 acre industrial parks are incentivised through PLEDGE (Promoting Leadership in Developing Growth Engines) where the development cost @Rs 50 per acre is provided at a 1% annual simple interest rate. 3 parks at Aligarh, Saharanpur and Kanpur Dehat have already been
- Through MSME Act 2020, acknowledgement. is issued to industries within 72 hours, which exempts them from inspection of any development for 1000 days
- Facilitation Council System has been decentralised to division level for effectively tackling delayed payments

SUPPORT MEASURES:

Financial assistance: The government will



provide financial assistance to MSMEs in the form of loans, grants, and subsidies.

- Tax incentives: The government will provide tax breaks to MSMEs, including exemptions from excise duty and sales tax.
- Infrastructure support: The government. will provide infrastructure support to MSMEs, such as land, power, and water.
- Training and skill development: The government will provide training and skill development programs to MSMEs to help them improve their productivity and competitiveness

The portal allows applicants to track their applications. All certificates and licenses are provided online after due verification. With a single registration, the beneficiary can take advantage of all services, including third-party verification, In one stroke, the CM turned an archaic process into a modern-day tool to attract investments



MSME Udyam Portal

MSME and Export Promotion Department has started a registration campaign on the MSME Udyam portal in the entire state. The Directorate of Industries is organising camps for the registration of MSMEs in each district. Additionally, MSMEs themselves can also register by visiting the portal. All eligible units can register. The objective is to provide a platform for active MSMEs in UP so that they can

There are more than 96 lakh active MSMEs in Uttar Pradesh, but only 14 lakh MSMEs are registered on the portal so far, while there are a large number of active MSMEs in the state that need to be registered to avail the benefits of government schemes.
