UP jumps to second spot in business reforms plan

It was easiest to do business in the states of Andhra Pradesh, Uttar Pradesh and Telangana in 2019, according to the rankings based on the fourth edition of the Business Reforms Action Plan (BRAP).

UP has achieved second position in the State Business Reform Action Plan 2019 -Ease of Doing Business annual ranking released by the Union Commerce Ministry's Department for Promotion of Industry and Internal Trade DPITT) in Delhi on Saturday.

The report was released by Finance Minister Nirmala Sitharaman and Commerce Minister Piyush Goyal.

UP has jumped from 12th position in BRAP 2017-18 to second position in BRAP-19, taking a remarkable leap of 10 positions. UP has left several leading states like Gujarat, Telangana, Rajasthan, and Maharashtra behind in the EODB ranking.
