Lucknow: With the international roadshows to invite investments in Uttar Pradesh ahead of the Global Investors' Summit-2023 coming to an end, UP has managed to get several MoUs in its kitty.

In the last leg of these meetings, the state got offers of investment from companies in San Francisco, Tokyo, Singapore and the Netherlands.

A delegation led by jal shakti minister Swatantra Dev Singh attended a round table conference in Singapore where over 20 companies participated and discussed investment opportunities in sectors like defence, basic infrastructure, education and urban development. MoUs worth Rs 8,500 crore were also signed in collaboration with Enterprise Singapore. The Indian delegation also met the minister of trade and industry of Singapore.

In addition to this, MoUs were also signed between Western Sydney University Parramatta and Gautam Buddha University in Noida-Greater Noida for cooperation and investment in areas such as urban agriculture, urban forestry, greening in cities, water conservation and student exchange programmes.

In Japan, tourism and culture minister Jaiveer Singh and technical education minister Ashish Patel met Kunihiro Funakoshi of Sysmex Corporation. Sysmex already has a presence in India and expressed its desire to expand its investment in medical device parks in UP.

The delegation discussed pharmaceutical advancement with Hiroyuki Akatsuka, associate director at the
