One-Day Workshop on Effective Implementation of PM Gati Shakti National Master Plan Held in Lucknow

Lucknow, March 10, 2025: A one-day workshop on the effective implementation of the PM Gati Shakti National Master Plan (NMP) was held on Monday at Indira Gandhi Pratishthan, Lucknow. Hosted by the Uttar Pradesh Government's investment promotion and facilitation agency—Invest UP, in collaboration with BISAG-N (MeitY), the event focused on insights, case studies, and best practices for using the Gati Shakti platform for comprehensive economic and social sector planning. Over 300 government officials from various districts and departments, including core departments like PWD, Energy, UPEIDA, and social sectors such as Health, Education, and Skill Development, etc, attended the workshop to gain insights.

Two technical sessions were held during the workshop on the following topics: "Demonstration on Enhancing PM Gati Shakti for Holistic Economic and Social Sector Planning" and "Leveraging SMP/DMP Platforms for Infrastructure & Social Planning: Experiences, Best Practices, and Future Roadmap."
