## Tata Group proposes AI City in state capital

CM Yogi and Tata Sons chairman discuss investment avenues in UP; TCS workforce in Lucknow, Noida to be increased from 16,000 to 30,000

AUCKNOW: Chief minister Yogi Adityanath on Monday met Tata Sons chairman N Chandrases karan to review the progress of the Group's existing projects in UP, and discussed their expan-sion and new investment pro-nosals.

The meeting saw wide-ranging deliberations on long-term cooperation in sectors such as artificial intelligence (AI), information technology, electronics, defence manufacturing, energy, renewable energy, electric vehi-cles (EVs), tourism, skill devel-

renewable energy, electric vehi-cies (Evs), tourism, skill devel-opment and the digital econ-omy, according to an official statement. Chandrasekaran proposed the development of an 'Al Chy' in Lucknow, aimed at position-ing Uttar Pradesh as a global hub for artificial intelligence, the statement said. The project is expected to strengthen the startup ecosys-tem and generate thousands of employment opportunities based on future technologies. The two sides also reviewed the progress of a Bs 48-crore Centre of Excellence being developed in Gorakhpur, which



is expected to provide advanced technical training and opportu-nities, particularly for youth from the Purvanchal region.

Discussions were also held on setting up a Global Capability Centre (GCC) in the state and expanding Tata Consultancy Services (TCS) units in Lucknow, Notda and Varanasi.

The proposal to increase the workforce at TCS Lucknow and Noida centres from 16,000 to 30,000 was described as a significant boost to the state's digital talent pool. Under a memorandum of understanding (MoU) with IIT-Kanpur, Tata Group initiatives will train youth in emerging areas such as Al., cybersecurity, data science, 3D printing, drones and space technology, helping create an industry-ready workforce, the statement said.

## Increased investment in Defence Corridor During the discussions, Tata

Sons chairman also proposed to invest in the production of mobile devices and other components, subject to the state government's approval. Chandrasekaran mentioned

that the Group has signed an MoU with Intel to promote manufacturing of electronic products in the state.

He discussed increasing

He discussed increasing manufacturing of electric buses, other vehicles, and their new models in the state. He also proposed increasing Taita Group's investment in the rapidly developing Defence Corridor in the state and highlighted the Group's contributions to UPs defence industrial nodes, including Babina, where the focus is on the production of drones, missiles and defence vehicles.

The chairman mentioned Tata Group's acquisition of 25,000 acres of land in Jhansi under BIDA and expansion of the project.

"MUSEUM OF TEMPLES' PROJECT
The two sides reviewed progress on the proposed 'Museum of Temples' project in Ayodhya, with emphasis on completing the first phase by January 2027. The museum will feature technology-driven displays aimed at attracting domestic and international tourists. Tata Group will also undertake the estoration of eight pomas Genga Kund, Shyam Kund, Radha Kund, Ashtakashi Kund, Nan Semri Kund, Garuda Gowind Kund, and Krishna Kund.

Kund. Additionally, the Tata Group will be responsible for cleaning major ghats along river Ganga across in

Chief minister Adityanath said the state government is committed to providing a stable policy framework, transparent systems and a business-friendly environment for invessions.

He expressed confidence that the multi-dimensional partnership with Tata Group would take the state's economy, employment generation and technological self-reliance to new heights.
