Key Policies and Incentives Driving Growth

One of the key pillars behind this significant rise is the Uttar Pradesh Warehousing & Logistics Policy 2022, a strategic move aimed at improving infrastructure while offering attractive incentives. Some standout features include:

- Capital Subsidy to ease financial burdens for new investments.
- Skill Development Subsidy, ensuring a skilled workforce to handle warehousing and logistics efficiently.
- Purchase Subsidy for setting up logistics parks, trucker parks, and warehousing facilities.
- Front-end subsidies such as incentives for setting up dry ports, cargo terminals, and silos.

These policies, backed by the efforts of Invest UP, have drawn global enterprises to establish their logistics and warehousing facilities in the state, transforming it into a logistics hub of international repute.

Impressive Climb in Logistics Ease of Doing Business Rankings

The Logistics Ease of Doing Business (LEADS) Rankings reflect the consistent improvement in UP's logistics ecosystem.  Streamlined regulatory processes through the implementation of the Nivesh Sarathi Portal, a one-stop solution for investors.

- Strategic partnerships with both global and domestic companies, facilitated by a probusiness environment created by the UP government.
- Proactive monitoring and support from Invest UP to ensure smooth project implementation and to address bottlenecks swiftly.

A Model for Future Growth

The initiatives taken by the state government under Shree Yogi Adityanath's leadership have not only improved rankings but have also set the stage for Uttar Pradesh to become the preferred logistics and warehousing destination in India.

Some of the notable achievements are:

- Uttar Pradesh has one of the largest storage capacities in India, with 689 railway goods sheds and 2,406 cold storages. The state's cold storage capacity is the highest in the country, making up 39.84% of the total national capacity (as per LEADS 2021).
- The establishment of mega logistics parks across the state, catering to industries ranging from FMCG to e-commerce.
- The state is developing integrated logistics parks and multi-modal logistics hubs to improve supply chain efficiency.
- The state is developing Multi-Modal Logistics hub at Dadri.
- The state is developing Multi-Modal Transport hub at Boraki.
- The state is making 100 PM GatiShakti Cargo Terminals for multimodal logistics facilities under PM GatiShakti National Master Plan 2021.
